Carol motioned, John seconded. • No approval for CCP so we do not have a financial report yet. • Membership applications are due, please submit them asap. • Officers nominations were last meeting, however Chuck has opted in to continuing, as he was not at the last meeting. We have Dave Wegner, Chuck Newton, and Rick Hollering as possible co-chairs.
