Meeting Notes (Old/New Business, Decisions, Agendas)

- Introductions
- Where do we want Red Ribbon, divided throughout categories or in Prevention? Steve motioned to keep it in Prevention and Will 2nd.
- Each category has \$9, 523.13
- Treatment category, each person was able to explain what they were requesting.
- YSA requested money for Celebrate Recovery, Snyder had four grants, and Women at the Well submitted a grant.
- Women at the Well was equipment to do meetings there in the resource center when they open. They will be utilizing SMART recovery.
- This category was over with all of the grants.
- Snyder offered to lower his indigent funds, Celebrate offered to cut off one cohort.
- Snyder was awarded \$2,000 for Indigent Funds, \$976.50 for books, \$500 for Spanish translator, and \$650 for a training.
- Celebrate Recovery was cut down to \$4,454
- Women at the Well received \$940.
- Ed motioned and Veronica 2nd treatment category.
- Law Enforcement discussed prior to reporting out, they were over in the category, however LPD opted to lower their amount to keep get it down.
- Juvenile Probation was \$3,000 for drug screens, Corrections was \$3,000 for workbooks, LPD was \$2,000 for IDEA training, and Cass County Sheriff's was \$1,500 for IDEA training.
- Tom motioned and Rick 2nd for Law Enforcement category.

- Prevention was over by a lot once Red Ribbon was added, Red Ribbon had a large chunk last year because of how much extra there was in that category.
 This paid for everything for the breakfast and the billboard for 3 months.
- Red Ribbon went back down to \$1,600. And YSA and Project HOPE lowered their grant request to stay within budget. YSA was awarded \$3,700 for youth empowerment and HOPE was awarded \$4,223 for monthly youth support groups.
- Ed motioned and Will 2nd for Prevention category.
- Administration funds were broken down \$7,800 for salary and \$1,723.12 for events/supplies.
- John motioned and Ed 2nd for Administration category.
- All categories decided, nominations for offices will happen next month.
- Rick motioned to adjourn and Veronica 2nd.
