We could use small items to give away. • YSA is donating fans, Stand UP has some items they will donate as well, please reach out if you have anything. • We can also use YSA tablets to do surveys on. New this year. They need to be set up, so anyone wanting to help with that can reach out. We just need to make the survey easily accessible for quick responses. We will also do paper surveys. • Please sign up for a slot to volunteer. You must have 2 hours volunteer time and attend 6 meetings through the year to qualify for funds in the next fiscal year, which would start next April. • Someone asked if the 4H had wifi, we will look into that.

- Do we want to adjust the surveys at all? We do use some of the data in our CCP, so keeping it the same from year to year is helpful for comparisons from year to year. Group decided not to adjust anything, what we have been using is working well.
